India is conducting quality research in many fields, but the country is lagging behind in patenting, according to National Research Development Corporation (NRDC) , Visakhapatnam Regional Manager Dr. B.K. Sahu, NRDC Chairman Dr. H. Purushotham

He was speaking after inaugurating a one day seminar on Innovation, Intellectual property right and at Dadi Institute of Engineering & Technology He said that "India is rich in research as it is ranked fifth in the globe in terms of research publications but poor in patenting". He said that The NRDC is engaged to broaden and strengthen the technology resource base by fostering long-term relationships with R&D organizations, MSMEs, PSUs, academia, technical organizations, and industries.



He said MOU with DIET which is due to be signed will provide expert services in IPR management, technology transfer, training, techno-commercial evaluation of technologies developed by faculty linkages with research funding agencies, linking to Startup India Mission and other relevant services.

As a resource person of the workshop he has given a lot of insights on how to work on research projects and how to get the funds to carry on the project. How one's ideas can be transformed and patented was clearly illustrated to the participants. He said he was moved by the innovative ideas of DIET students and asked them to patent and apply for funding.

The Chairman of DIET Sri Dadi Ratnakar asked the faculty and students to come up with quality research works and get them patented.

Principal Dr.Ch.S.Naga Prasad said that the session was arranged to facilitate the faculty to enhance their research capabilities and to develop an ecosystem to carry on with research works to be patented.

The Project Review committee convener Dr. K.Sujatha has motivated and assured the students of necessary assistance to carry on with their projects. Heads of all Departments, faculty and students participated in large numbers.

Around 30 participants have participated in the event participation awarded to all the delegates.
