

## "Awareness on Health Care"

Awareness on Health Care activity was conducted by NSSTEAM of DIET on January 6-1-2021 to 8-1-2021.

In this activity, students and staff have participated. Serviced the village people by understanding their health issues and how it can be overcome the given problem Principal Sir addressed the activity and told the importance of health monitoring and service for the village for the betterment of the village population and Hygiene.



Respected Chairman, Sri Dadi Ratnakar Garu alsostressed on the importance of Health Service and Importance of activity and betterment of Community Service.

The voter awareness campaign was conducted inThummapalaof Anakapalle, Andhra Pradesh.

In this activity DIET NSS officer, Principal and Chairman Sir addressed the activity and all HODs, Staff encouraged the student to conduct such community service activity.

## Awareness on health care

The only way to provide palliative care to a huge number of people in need in India is through community participation, which was achieved by improving the awareness of the people about palliative care The NSS Team conducted a activity to assess the impact of health awareness campaign in improving the awareness of people about palliative care.

This activity conducted in Thummapala village of Anakapalle in visakhapatnam district, Andhra Pradesh. One respondent each from all the households in the village was interviewed regarding the knowledge and attitude on Health care before and after the health awareness campaign using a pretested questionnaire. Health awareness campaign consisted of giving door-to-door information, and general interaction with Health team in the village.

The awareness regarding health care during the interaction was nil. After the intervention, it increased to 50% (estimation). However, there was a decline in the attitude and the interest of the people toward health care.

#### Variables included in questionnaire

- Socio demographic variables: Age, gender, education, occupation, socioeconomic status, and type of family
- Medical details: Morbidities and disabilities
- Need for palliative care in respondents or any member of the household
- Awareness regarding palliative care
- What is palliative care (components?)
- Conditions requiring palliative care
- Who can provide palliative care?
- Role of community volunteer?
- Perceptions of the need of palliative care in the community
- Perception regarding the best place such care can be provided

#### **RESULTS**

A total of 110 participants were interviewed. There were both female and males in the study population, almost all belonging to nuclear families. Majority (68.2%) were from the lower most classes of the socioeconomic groups with 40% without any education

In all the households, there are no bedridden people but there are people suffering with different types of sickness' such as Blood pressure, High or low Blood Sugar levels, poor eye sight, dizziness, pain, cough, breathlessness, fatigue, loss of appetite, etc.

In the prevntervention survey, some in the village had heard the term "Health care/end of life care/home care for bedridden people/community-based care." The campaign was attended by at least one member in 74 out of the 110 households. After the campaign, 91 participants were aware of the term health care.


Fig 2:Awareness on Health for Teacher






Fig3:Awareness Health tips for women




Fig4:Awarness Health tips for Old Person
