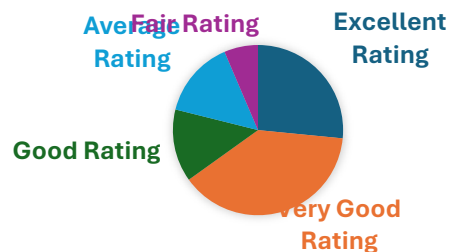

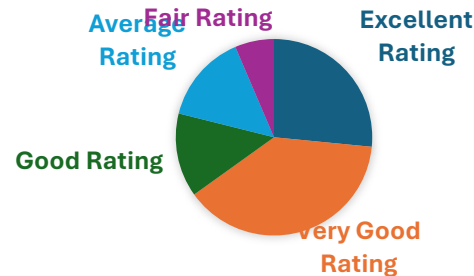

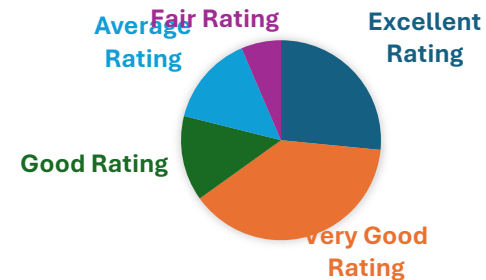

OBSERVATION:

- Students often appreciate a curriculum that is closely aligned with their academic and career goals, incorporating up-to-date theories, industry practices, or real-world applications.
- A balanced curriculum with manageable workload and appropriate pacing can boost student engagement and reduce stress.
- Clear learning objectives, logical progression of topics, and well-structured modules are often highlighted positively. When students understand the "why" behind each part of the curriculum, they can see the bigger picture of their learning journey.
- Students feel that the curriculum relies too heavily on lectures or rote memorization, they may seek more interactive, problem-based, or experiential learning activities. Additionally, outdated or difficult-to-navigate textbooks or materials may hinder student engagement.
- Students often appreciate having choices in how they engage with the curriculum, such as elective courses, project-based learning opportunities, or flexible deadlines.

Summarized Action Taken Report from IQAC

Based on these observations, the following actions are recommended for IQAC to enhance the educational environment

1) Evaluation Process Review

Conduct regular audits of the evaluation process to ensure ongoing impartiality and transparency addressing any concerns that might arise

2) Curriculum Relevance for Career and Research

Collaborate with industry partners and academic advisors to ensure curriculum relevance with potential curriculum updates to better serve students in their career pursuits.
