Differently abled (Divyangjan) friendliness

1. DIET college provides facilities to differently abled students to attain education without any hindrance and make them an equal part and parcel of the society. The provision for wheel chair is provided with an assistant to escort the differently abled students to their respective classes. DIET college has a special concern and honor to serve these students and make them feel comfortable unlike other students, to impart quality education.



2. Separate washrooms are available for differently abled students and staff. Facilities inside the washrooms are made available for easy accessibility like mounted dispensers, flushing facilities, wide doors for wheel chairs to pass by, proper door locking and releasable system, mirrors, tables to keep their belongings etc. for easy utility
3. Ramp/Rails: The college has provisions for ramps & rails for differently abled students. The main entrance is equipped with ramps and assistants to facilitate wheelchair users

and accompany the differently abled student to their respective classrooms or assist them to get through the lift.



4. Diet college provides the facility of scribes to assist differently able and visually impaired students during examination. As per the Government Circular ED 5 UNE 2004, dated 5.3.2004 and ED 5 UNE 2004, dated 22.3.2004, the following guidelines are to be strictly followed:
 - a) The blind student may select the scribe.
 - b) The scribe need not have a qualification lower than that of the student, provided that the scribe should not have the qualification (with the same optional and languages) pertaining to the examinations, which the student is writing (for ex: a student who has completed B.A. or M.A. can be a scribe for the student who is taking B. Sc. Examinations)
 - c) A physically disabled / blind / hearing impaired candidate and the scribes for such a candidate shall be allowed an extra time of 20 minutes per hour.
 - d) As the hearing-impaired students are having language problems, possibilities of grammar mistakes, mistakes in building the sentences are there. Hence, the answer papers shall be identified separately and evaluated with additional care.

5. DIET college has provision of Lift for differently abled and visually impaired students with an assistant to assist and guide them towards their respective classrooms. The lift has wide opening for wheel chairs to accommodate and has enough space. It is provided with reachable easy control panels to navigate. Accessible outdoor parking spaces is provided close to the lift area. Visual and audible signal is facilitated during the entrance and exist at all the floors. The lift is enabled with bright lighting and fan facility.



6. College has the provision to provide Software facility for Visually Impaired students and the students who suffer from low vision issues or partial blindness etc. The software can easily convert speech to text and text to speech. The visually impaired students can speak to convert voice into text. The students would be provided with an assistant to read the text and convert as audio source for their future reference. The text material can also be converted to speech or voice and the recordings can be used by the student to attain the concepts clearly.
